Deb celebrated how everyone is safe after the snowy road conditions. April celebrated the Future Cities project and field trip to Novi happening next week. Jessica celebrated the Voyage of Discovery fundraiser meeting that recently happened; it was good to hear the needs and desires from parents. Joe celebrated by complimenting Jessenia and the way she structures and organizes the board meeting space and time. Laurie celebrated the communications from Leisa; they are positive, timely, and well-informed. Abbie celebrated the kids being back in school today after all the snow days. Dave celebrated how we are almost halfway through the year and it's been going smoothly.

7. School Report

a. 2024-2025 Open Enrollment Seats
Still waiting to hear back from 158 students. Leisa re-sent the survey to parents today. Proposed number of seats have added a couple seats to two of the classes from 22 to 23. Ask to remain closed to any new 8th grade students because they will not be attending Innocademy next year.

8. Financial Report

a. January Financial Report

Revenue at 27% compared to 24% last year. Still a little bit ahead. Still under 50% for instruction expenditures. Support services at 40% compared with 46% last year. Debt service at 46% compared to 45% last year. Cash in the bank is up from where it was last year.

b. Quarterly Financials Report

This is synced up against the December budget. Includes copy of the balance sheet and labeled as Quarter Ending. Installation of sink and kiln – which are great additions to the building.

c. Budget Amendment #1 Report

Dave presented a summary of the budget amendment and it is in a good place. A fairly decent sized gas rebate will be coming from Semco which is good for our revenue. State Aid Status report is up for section 22b which is good news. The state has a lot of grants which is great but also a lot of work. Mental health and school safety are now coming from one grant instead of two – Section 31aa. A lot of money is available in the GSRP that Innocademy receives, which allows the full day and half day program to continue as well as add another half day and to improve the spaces. Federal funding from Title IA is also helpful this year.

Mental health grant money is creating a partnership with Mosaic to provide therapy for teachers and their immediate families; Mosaic is also offering support to students who don't qualify for free mental health services. Also using money to support community building events that support and strengthen the social bonds of Innocademy.

School safety – working with a company to get a quote for cameras, check-in procedures, and the ability of the front desk to interface with teachers in the building, to help strengthen the safety of access to the building.

At Risk funds – shifting some of the funding to a class-size reduction model as well

as the purchase of intervention related software.

ESSER III - helping pay for ELA curriculum.

MS Capstone Trip – 12 of the 14 students going. Students will only have to pay \$200 out of pocket.

Net improvement: deficit has gone down significantly since July but still not at 0 yet. School still has a healthy fund balance (29.6%). Need 10-15 more students to get to a sweet spot for the long term budget.
